This Memorandum of Understanding (the "MoU") is entered into on 11<sup>th</sup> February 2016 between **Department of Women and Child Development, Government of Maharashtra** having its office address at 3rd Floor, New Administrative Building, Opposite Mantralaya, Mumbai - 400032, Maharashtra, India (hereinafter referred to as "DWCD"), **The Children's Aid Society** having its office address at 83, T. H. Kataria Marg, Mahim, Mumbai - 400016, Maharashtra, India (hereinafter referred to as "CAS") and **JSW Foundation**, a public charitable trust, having its registered office at 6, Prithviraj Road, New Delhi and Administrative Office at Jindal Mansion, 5A, Dr G. Deshmukh Marg, Mumbai - 400026, Maharashtra, India (herein after referred to as ("JSWF") and henceforth collectively both are referred to as "parties" to this MoU.

WHEREAS, DWCD is the nodal department of Government which governs the implementation of schemes for welfare of women and children with specific focus on their growth, development and protection.

WHEREAS, CAS is running seven residential institutional Children's Homes in Mumbai for providing Care, Protection, Treatment and Development of Children to ensure they are effectively rehabilitated.

WHEREAS, JSWF is a public charitable trust formed under the Indian Trust Act 1882 working in various areas of Social Development including Primary, Secondary and Vocational Education for the children, especially Girl Children, Facilitate equal opportunities for women at work place with continuous engagement in JSW's workforce, Set up public health institutes to address issues like malnutrition, hygiene, clean drinking water, HIV-AIDS and early marriage etc.

**This MoU is being entered into for collaboration on Delivering of Quality Services to the resident Children in Dongri Observation, including its effective monitoring and Institutional Strengthening.**

WHEREAS parties in principle agree to cooperate, to have further dialogues and to further negotiate and finalize the mutual beneficial relations.

Now in consideration of the premises the parties hereby agree as follows:

**Scope of work/activities to be carried out by JSWF:**



1. Study Best Practices followed Nationally and Internationally on running Child Care Institutions (Observation Homes) and come up with relevant benchmarking and recommendations
2. Provide co-operation in Staff Support to the Observation Home by supporting the Staff Vacancies/ Gaps
3. Work closely with CAS to ensure that the Library in Observation Home has required infrastructure sufficient for catering to the children in the Observation Home and that the library has at least 10,000 books collected by various ways such as Book Donation Camps etc.
4. Provide co-operation in Skill Development/ Vocational Trainings to the children to ensure they become a part of the mainstream and that they are effectively rehabilitated.
5. To help develop kitchen garden in the premises of the Observation Home for providing Micronutrient rich diet to the children and create a sustainable and low cost source of Vegetables and Fruits from within the premises. JSWF shall also endeavour to train the interested children on developing Kitchen Garden as part of their skill development
6. Facilitate in carrying out Periodic Eye Check-up camps for the children
7. To level top soil area for playground so the children have safe access to Outdoor Sports
8. Facilitate Sports Activities through Magic Bus
9. Arrange for Industrial Excursions to nearby industry at least once in three months if feasible to inculcate importance of Vocational Education in children.
10. Painting the walls of the Premises to as part of cleanliness and beautification
11. Any other activities decided mutually from time to time

**Scope of work/activities to be carried out by DWCD & CAS:**

1. DWCD & CAS shall facilitate all the necessary approvals and go-aheads required for successful execution of this project.
2. DWCD & CAS shall not provide any financial support for execution of this programme, however, the frontline staff of DWCD & CAS shall support JSWF for carrying out the programme implementation in effective manner

**General Provisions:**

- i. The parties understand that neither this MoU gives any right to any party, nor does it creates a partnership, joint collaboration or employment as a result of this MoU.





- ii. Prior to signing of this MoU, each party will bear all of its own expenses necessary to meet its duties and obligations under this MoU. Neither party can create or cause to create any charge against the other party as per this MoU.
- iii. All the Terms & conditions mentioned in the Department GR No: ICDS-2015/ C.R. 31/ Desk 5 dated 20<sup>th</sup> May 2015 regarding Implementation of Corporate Social Responsibility (CSR) initiatives for Women and Child Development Department, Government of Maharashtra shall be binding on Riddhi
- iv. The representatives of each party shall monitor the progress of the initiatives undertaken under this MoU

**Validity of the MoU Agreement:** This MOU will come into effect on date of signature by all parties and will end after 3 years from the date of signing of this agreement.

**Amendment:** This MOU may be varied at any time by mutual agreement of the parties in writing. It shall be reviewed one month before the end of contract date or at a time mutually agreed by the parties for possible renewal.

**Termination:** The parties may terminate this agreement after giving a notice of 30 days to other parties




